

District Manager Michael McElligott called the May 10, 2022, Regular Board Meeting of the High Ridge Quantum Community Development District to order at 9:00 a.m. in the Conference Room of Special District Services located at 2501 A Burns Road, Palm Beach Gardens, FL, 33410.
