A. CALL TO ORDER

District Manager Michael McElligott called the November 8, 2022, Regular Board Meeting of the High Ridge Quantum Community Development District to order at 9:09 a.m. at the Special District Services, Inc. conference room located at 2501 A Burns Road, Palm Beach Gardens, Florida 33410.

B. PROOF OF PUBLICATION

Mr. McElligott presented proof of publication that notice of the Regular Board Meeting had been published in *The Palm Beach Post* on September 30, 2022, as legally required.

C. SEAT NEW BOARD MEMBERS

I. APPROVAL OF MINUTES 1. September 13, 2022, Regular Board Meeting

Mr. McElligott presented the minutes of the September 13, 2022, Regular Board Meeting and asked if there were any changes and/or corrections. Mrs. Drum point out a typographical error in section I. There being no other changes or corrections, a **motion** was made by Mrs. Drum, seconded by Mr. Patterson, and unanimously passed to approve the minutes of the September 13, 2022, Regular Board Meeting, as amended.

J. OLD BUSINESS

There were no Old Business items to come before the Board.

K. NEW BUSINESS

1. Consider Resolution No. 2022-04 – Adopting a Fiscal Year 2021/2022 Amended Budget

Mr. McElligott presented Resolution No. 2022-04, entitled:

2. Consider Approval of Auditor Renewal

Mr. McElligott informed the new Board members that while we advertise for a monthly meeting, we typically only hold about 4-5 meetings a year. Mr. McElligott said he expects the next meeting to be in February or March of 2023.

M. BOARD MEMBER COMMENTS

Mrs. Drum informed the District that she has officially changed her name to Kelli Martin, as a result of her marriage. Mr. McElligott explained that he would begin the process of getting her name updated going forward, but that any supervisor payments and/or other documents from this meeting might still use her prior name.

There being no further business to come before the Board, the Regular Board Meeting was adjourned at 9:21 a.m. on a **motion** made by Mrs. Martin, seconded by Mr. Patterson, and the **motion** carried 4 to 0.

This firm's current fee structure has been in place since 2011. Although we are certainly mindful of the necessity to keep increases in the District's expenses, including the cost of legal services, to a minimum, it has become necessary for us to adjust our hourly rates effective, April 1, 2023 as follows:

•	Attorneys/Partners:	\$275.00 per hour
•	Attorneys/Associates:	\$225.00 per hour

This hourly fee structure will be adjusted on a periodic basis in connection with the District's budget process no later than every third Fiscal Year to reflect changes in the Consumer Price Index published by the U.S. Department of Labor. The CPI has reflected a 31.8% increase since the year 2011 and we have not raised our fees during that time.
